CENTRAL MARIN NEIGHBORHOOD RESPONSE GROUP (NRG)

A Short History & Updated Info

You may not know that the NRGs started right here in Mariner Cove. We're proud to say that the idea took off and now there are 41 NRGs in Central Marin, covering about 6,000 households. Our Corte Madera NRGs have the full support of our town and have become an integral part of disaster planning for the Town.

Our Mariner Cove NRG is part of The Central Marin NRG, which gives guidance to all the NRGs. We run independently but have the benefit of broader information that makes us stronger.

Your Mariner Cove NRG leads, Lee and John Howard and Suzi Beatie, continually participate in Central Marin NRG. We are on the Advisory Committee and fully involved – this puts Mariner Cove's NRG in a great position as we are aware of almost everything disaster-related in our community.

Some of what we send out to you will only relate to Mariner Cove, but we try to keep you informed of all community-wide disaster issues.

Presently the focus of Central Marin NRG as it relates to you includes:

FIRE – we don't tend to think of that as being a huge problem here in the flatter lands on the Bayside, but fire is an issue everywhere. Thanks to the passage of Measure C, there is a lot going on right now to attend to problem areas and manage overgrown vegetation. There was a Chipper Day (a town paid event for the disposing green waste) at The Cove parking lot in July. Humongous amounts of vegetation were cleared – making us safer in Mariner Cove! There will be more of these events – keep an eye on Nextdoor for announcements.

EVACUATION – routes are being identified by Central Marin Fire and will be published soon, including Community Refuge locations which will be identified. These are safe places near your home where you might go temporarily in case of an evacuation. We will help keep you informed.

MAPPING – evaluating digital forms to map and identify locations of various NRGs.

TRAINING – helping NRG Teams learn and retain skills during COVID time is challenging.

Radio workshops and medical protocol must continue. COVID won't stop just because we have an earthquake or fire.

EDUCATION – ongoing info for both the disaster teams and the community is vital.

We work with PG&E and other groups on a series called Timely Topics. These educational programs were originally planned to be held at the Corte Madera Community Center – now they are on Zoom and we get great turnout!

TEAM SUPPLIES – medical bags have been provided for our Medical team. New OK/Help signs are available for those who need them.

We thought you'd like to know a bit of what goes on behind the scenes. That's all for now!

MARINER COVE DISASTER DRILL

When a major earthquake strikes Mariner Cove, we have several teams of your neighbors who will respond – Block Captains, a Command Team, and a Medical Team. We have 56 Block Captains who, after caring for their own families, will patrol their assigned cluster of nearby homes to identify hazards and injuries. Our Block Captains report via radio to the Command Team who have gathered at the Disaster Trailer behind The Cove School. The Command Team is comprised of 17 members and their job is to record reports from the Block Captains and work to solve the problems. The third team, the Medical Team, consists of 18 medically-trained neighbors and it is divided into two groups. One group reports to the trailer to oversee the medical responses while the second group (the Field Medical Team) stays in their homes until dispatched into action at which point they grab their bags of medical supplies and their radios and report to the site of injuries.

The last drill was held on March 8th. We had simulated events in 12 of our 23 clusters and the members of our Medical Team were kept busy as they worked to deal with the injuries. In this drill, we had a new objective: coordinate with the other five Neighborhood Response Groups on the Bayside of Corte Madera. In a real earthquake, we will rely on Mutual Aid so communications between all six of these Command Teams will be vital. The Command Teams also have the ability to relay messages through CERT (Community Emergency Response Team) to the County Sheriff who is responsible for responding to the entire disaster area.

OUR NEXT DRILL IS NOVEMBER 1

We will carefully observe the virus protocols by wearing masks, gloves and observing the six-foot distance.

We are always ready to welcome new members to any part of our Neighbor Helping Neighbor Team. We are especially in need of folks who have taken the CERT course and who could help us in Search and Rescue situations. We provide new Block Captains, Command Team, and Medical members with an orientation and a radio and a warm welcome. MARINER COVE BEAUTIFICATION AND INFRASTRUCTURE

Public Works is overseeing several projects in Mariner Cove but the Board of Directors decided the thirty-year old entrance signs for Mariner Cove needed clearing, cleaning, and painting. These signs were originally commissioned by the MCNA and have stood up well but just as our houses need restoration and painting, so do the signs. Please slow down and take a look as you enter our neighborhood.

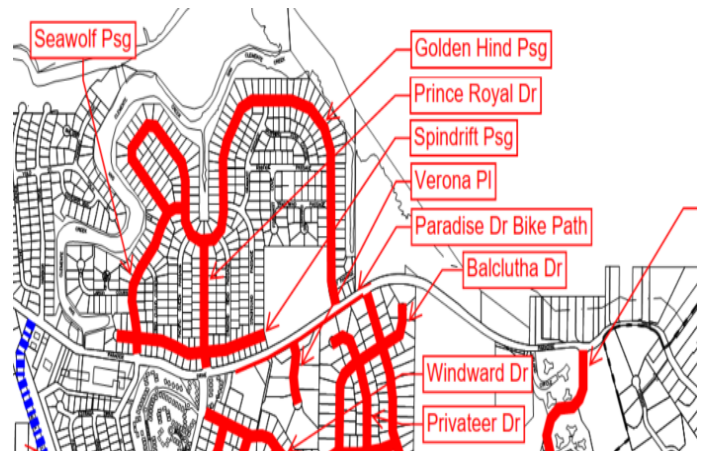


There are new ADA approved curb cuts on all our streets so crossing will be safer for everyone and especially anyone with mobility issues. That is not the case with many of our sidewalks and the Board wants to remind all residents that homeowners are responsible for maintaining their sidewalks so no pedestrian is at risk of falling on an uneven surface. Homeowners are liable if someone is injured so it is in our best interest to repair any unsafe sidewalk.

Pacific Queen Passage and Flying Cloud Passage will be regraded and paved next year and our Engineering Department believes this will significantly improve the ponding problem on these streets. This summer the Corte Madera Sanitation Department will replace the main sewer lines on both streets. Residents of these streets may be encouraged to survey and replace if necessary their sewer laterals in conjunction with the repaving as this will be a significant cost savings if they do not have to open the street and replace the portion of the line that the Sewer District will replace.

This summer there will be a slurry seal on Golden Hind Passage, Prince Royal Passage, Seawolf Passage, and Spindrift Passage to upgrade the pavement on these streets. A slurry seal is designed to prevent the more expensive regrading and repaving such as will be done on Flying Cloud Passage and Pacific Queen Passage.

The roads highlighted below will receive a slurry seal this summer:



There will be some pothole repairs on Paradise Drive between San Clemente Drive and Seawolf Passage this summer with repaving in 2021. Public Works is also looking to widen the sidewalk along the north side of Paradise Drive between San Clemente Drive and Seawolf Passage as part of a Safe Routes to School project. This will impact some homeowners in Mariner Cove but the details have not been released.

The Climate Adaptive Plan for Corte Madera was presented at a June 18th workshop and is available for viewing. The possible plan for dealing with sea level rise as it relates to Mariner Cove and Marina Village is presented in the document. It is available online (<https://storymaps.arcgis.com/stories/76987733ccc04ab2a3e5e5634aff4f28>) and residents are encouraged to view the program and make any comments regarding any of the proposed plans.

SCHOOL LIAISON UPDATE

With the COVID-19 pandemic, our schools and children were challenged to shift to distance learning and maintaining friendships and connections with classmates over Zoom. I know first hand this was very difficult for them, but they rose to the occasion.

The LCMSD had anticipated moving to in-person learning for the 2020 school year, but due to a recent spike in COVID-19 cases, Governor Newsom has outlined updated State guidelines and conditions for in-person instruction that affect our district.

Here are the primary guidelines the State issued, current as of July 31, 2020.:

- Schools located in counties that are on California's Monitoring List (Marin is currently on this list) must not physically open for in-person instruction until their county has come off the Monitoring List for 14 consecutive days.
- Schools should revert to distance learning when multiple cohorts have cases or 5% of students and staff test positive for COVID-19 in 14 days.
- The district should revert to distance learning when 25%+ of its schools have been closed due to COVID-19 within 14 days. Closure decisions should be made with local health officers. After 14 days districts may return to in-person learning with approval of the local public health officer.
- All staff and students in 3rd grade and above are required to wear masks. Students in transitional kindergarten through 2nd grade are strongly encouraged to wear masks.
- Adults must stay 6 feet away from children and other adults. Students should maintain 6 feet of distance when possible.

- Staff in every school should be tested for COVID-19 periodically. The state will provide technical assistance.
- Schools must provide rigorous distance learning, which means: devices for all students, daily live interaction, challenging and equivalent to in-person instruction, and targeted supports for English Learners and students with disabilities.

Since Marin is currently on the California Monitoring List, the LCMSD will have to begin the 2020 school year with distance learning, but is prepared for two other scenarios should guidelines change:

1) in-person learning, 2) a hybrid of in-person and distance learning.

Below are details of the core components of the LCMSD Distance Learning Program.

- Regular live instruction
 - Elementary students will receive an average of 100+ live instructional minutes per day plus small group instruction as identified by their teacher (along with independent work)
 - Middle school students will follow a distance learning bell schedule with an average of 175+ live instructional minutes per day plus small group instruction as identified by their teacher (along with independent work)
- Weekly feedback
 - Students and parents will receive weekly feedback via Alma (our student information system) and/or Google Classroom/Google Suite
- Common platforms
 - Grades K-1 will use the Google Suite for assignments and feedback
 - Grades 2-8 will use Google Classroom for assignments and feedback
 - Clever integration will allow you and your students to sign in to accounts and

programs from one location without having to enter a password each time. Younger students can also hold up QR codes to the camera to sign into accounts (no more passwords for K students!).

- Zoom and/or Google Meet for live session delivery
- Attendance and participation are required
 - There will be attendance and engagement requirements for all students – distance learning is not an option
- Middle school electives
 - Will be offered through our seven period distance learning schedule
- Elementary school specials (art, music, physical education)
 - Will be offered virtually
 - Specialists will also provide student support, intervention, and outreach
- Special education, intervention, and English learner services
 - Will be provided virtually and in person as permitted
- Stable cohorts
 - We will create stable classroom cohorts in the event that we can transition to in-person instruction
- District provided student devices
 - An email will go out shortly to request student devices (hotspot, iPad/Chromebook)

The 2020/2021 school year will look dramatically different than previous years based on the new guidelines but the LCMSD is working to create the safest conditions possible on campus to protect students and staff from COVID-19 once they return. Please watch for emails from the LCMSD for further updates on specifics for your school.
